2021 Rock Ridge Country Club Membership Agreement

Conditions of the 2020 Membership Offer:

- 20% off dues and assessments May, 2021 through December 2021
- 10% off dues and assessments from January 2022 through December 2022

By electing to join, I agree to the following terms and conditions as they relate to joining Rock Ridge Country Club:

1. **\$1,000 Promissory Note Signature Required.** All joining members under the 2020 Membership Offer will be subject to signing a \$1,000 forgivable promissory note for a 1 year commitment to membership. This 1 year commitment period begins with the month the member starts paying dues and the note becomes void if the membership continues beyond the one year commitment period.
2. **Dues and Assessments.** Upon securing membership, monthly dues and assessments will be discounted 20%, applicable to the category of membership in which you are approved through December 2021. Starting January 2022 through December 2022, monthly dues and assessments will be discounted 10%, applicable to the category of membership in which you are approved. Monthly Dues and Assessments are billed in advance. Discounts apply to all operating and current capital assessments.
3. **Stock Fees.** Full Golf, Junior Golf and Single Golf membership classes are required to purchase two shares of non-refundable and non-transferable stock; Weekday and Social membership classes are required to purchase one share of non-refundable and non-transferable stock.
4. **Rock Ridge Country Club By-Laws and Rules and Regulations.** I agree to be bound by the By-Laws and Rules and Regulations outlined in the Member Handbook ("the Green Book") as established and may be amended by Rock Ridge Country Club from time to time. I acknowledge this is an annual membership that is billed monthly for my convenience and will automatically renew on December 31st. Cancellation of this membership is only allowed once a year on December 31st. Notification of such cancellation must be received on or before December 31st. I further acknowledge that a notification of cancellation does not relieve me of any payment obligation of costs associated with the membership including dues, assessments and all usage that occur from the time of such notification through the end of the year (December 31st). I hereby accept that I will be held personally liable to pay all club dues, club charges and club assessments that have been incurred by me including but not limited to all attorney fees and court costs associated with the collection of any debts owed to the Club.
5. **Recallable Membership.** The club has the absolute right and discretion to recall my membership at any time before the relationship terminates. If the club exercises its right, I remain obligated and promise to pay all charges incurred through the end of the month in which the club exercises its right to recall my relationship.
6. **Final interpretation.** The club reserves the right to make final decisions pertaining to all matters regarding the 2021 Membership Drive.
